ABSTRACT

Abstract is an epitome of paper. It should start three lines after the authors' introduction. Written with single spacing, the abstract should not exceed 300 words, without equations, no references, and preferably only one paragraph. Use "times new roman" 12 points and fully justified. Three to six keywords should be provided. Leave two blank lines after the keywords, and then start the main text. All manuscripts must be in English. The length of submitted paper should be 6-12 pages long.

1. INTRODUCTION

Please strictly follow these guidelines while preparing the manuscript. For section title, please use bold, capitalized and times new roman 12 points. For the body text, use times new roman 12 points, and for the sub-section title, use **bold** times new roman 12 points. All parts should be completely justified.

New paragraph should be started in indented style instead of entered style. References should be cited by specifying the authors' name and publication year. For Example: Smith (2016) reported that The references should be listed by alphabetical order of the first author's last name.

2. SPACING AND PARAGRAPH

2.1 Margins and Spacing

Use the following margins: 1” for top and left, 0.9” for right and bottom. Single spacing should be used throughout the paper. Enter once before a section or a sub-section begins.

2.2 Paragraph

New paragraph should be started in indented style instead of entered style. References should be cited preferably specifying the authors’ name and publication year. For Example: Smith (2016).

The references should be listed based on alphabetical order of the first author’s last name. Examples are given at the end of these guidelines.

3. FIGURES AND TABLES

3.1 Figures

Each figure should be numbered and have a caption centered below it as follows:

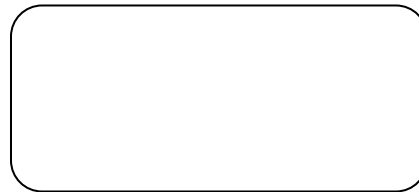


Figure 1: Figure expression

6. REFERENCES

List the references in alphabetical order of the last name of the first authors. Please indent the second and the following lines in each reference. Journal articles, conference proceedings and books should be clearly distinguished. Sources from the internet should be accompanied by their URL (this does not apply for journal articles taken from electronic sources as long as they have the journal names, publication numbers, and page numbers). See example.
